From the North: Take 495 South, exit the highway at Exit 28 (rt.111). At the end of the exit turn right and go over the bridge. Take a right on to Adams Place (across from the gas station). Drive down Adams Place to the Inn parking lot. Go in the first entrance and turn left, park down by the trees at the north end of the lot. The field is across the street and up the small hill.

From the South: Take 495 North, exit the highway at Exit 28 (rt.111). At the end of the exit turn left. Take a right on to Adams Place (across from the gas station). Drive down Adams Place to the Inn parking lot. Go in the first entrance and turn left, park down by the trees at the north end of the lot. The field is across the street and up the small hill.

Field parking: As you drive down Adams Place there is a dirt road on the right that has a chain attached to a post. If you drive down that road, it ends at the show field. Please no motorhomes as the trees are too low to enter.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS TO ITS ACCEPTANCE.

ENTRY FEES shall not be refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Show Committee. If because of riots, civil disturbance or other acts beyond the control of management it is impossible to open or complete the show, no refund of entry fee will be made. Overpayments may be picked up at the show only.

ERRORS ON ENTRY FORMS: Owners are responsible for errors in filling out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after published closing date.

DOGS MAY ARRIVE any time prior to their scheduled time of judging.

DOGS NOT REQUIRED FOR FURTHER JUDGING will be excused.

OWNERS AND HANDLERS will be responsible for the dogs at ringside when the classes are called to be judged. Judging cannot be held up to locate absentees.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercise ring.

THIS SHOW MAY BE CANCELED according to AKC rules in event of extreme weather.
