I (we) agree to hold the AKC and any AKC approved judge harmless from any legal claim resulting from said AKC judge's action under the "AKC Rules, Regulations and Guidelines."

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. Entries will not be accepted without fees. Returned checks do not constitute a valid entry. The Herding Secretary will add a collection fee to the amount of each returned check. Canadian exhibitors must submit entries with an international money order guaranteed in U.S. funds.

If sending entries overnight, make sure to **sign the waiver** that allows them to leave packages without a signature, Requiring a signature will only delay receipt of your entries.

**A separate entry form must be submitted for each entry.** Entries not on official AKC entry forms or photocopies with out the agreement and rules are unacceptable. Telephone, telegraph, fax and unsigned entries cannot be accepted. Changes additions or corrections to entry forms must be received in writing prior to the close of entries. No refund for duplicate entries or any other cause beyond the control of the club after the closing date.

The club may decline entries for cause and may refuse to receive or remove any dog on account of disease, viciousness, or other cause and no one shall have any claim or recourse against the club or any official thereof.
